## MEET THE JUDGES

**EDWARD M. BINKLEY** IS THE National Design Director for Des Moines, Iowa-based Bloodgood Sharp Buster Architects & Planners, and partner in charge of the firm's Orlando, Fla., office. He has been involved in award-winning design projects since 1979 and has a passion for low-income and Third World projects.

**Glenn Cardoso** is principal of Santa Monica, Calif.-based New Urban West, a developer and builder of medium-sized, upscale master planned communities and most recently urban mixed-use projects. Cardoso currently serves as a board member of Home Aid America.

**Mark Grassi** is president of Napa, Calif.-based Grassi Construction. Established in 1986, the firm has grown to become one of the leading custom home and winery builders in the Napa Valley. Recent projects include a contemporary cast-in-place concrete home and a replica of an 18th-century French chateau.

Following the destruction of Hurricane Katrina, Moule participated in the design charrette and subsequent reconstruction efforts in the town of Biloxi, Miss.
